**IT IS EXPRESSLY UNDERSTOOD AND AGREED** that if Principal should withdraw its Bid anytime after such Bid is opened and before official rejection of such Bid or, if successful in securing the award thereof, said Principal should fail to enter into the Contract and furnish required submittals, including satisfactory Performance, Payment and Maintenance Bonds, along with certificate(s) of insurance evidencing required coverages and limits, the Obligee, in either of such events, shall be entitled and is hereby given the right to collect the full amount of this Bid Bond as liquidated damages, which is hereby acknowledged as the amount of damages which will be suffered by Obligee on account of the failure of Principal to perform such obligations, the actual amount of such damages being difficult to ascertain.

**PROVIDED**, the Surety, for value received, hereby stipulates and agrees that the obligation of said Surety and its bond shall be in no way impaired or affected by any extension of the time within which the Obligee may accept such Bid, and said Surety does hereby waive notice of any such extension

**PROVIDED FURTHER**, that if any legal action be filed upon this Bond, venue shall lie in Galveston County, Texas.
